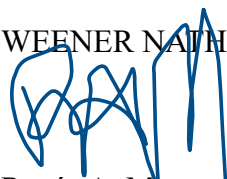

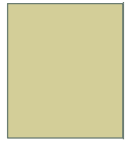

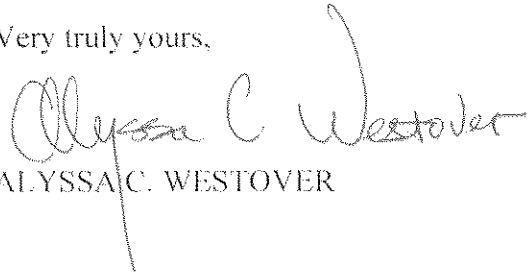

To whom it may concern:

I write to commend you to the expert services of Dr. Jay Grossman. I have found that experts typically exist on a spectrum with credibility on one side of the spectrum and litigation savvy on the other. I prefer the former, but those come with a certain anxiety as they can forget the importance of articulating opinions in the language of “reasonable degree of medical certainty,” offer tangential and unhelpful observations, are sometimes flustered by opposing counsel, and other limitations born of either inexperience or disdain for the process. On the other side, an experienced expert often appears too invested, too much an advocate, and loses credibility.

The ideal expert has the experience and awareness of the role of an expert witness, as distinct from an academic commentator, but presents as an objective and dispassionate observer. Dr. Grossman is such an expert. He is a quick study on the issues in the case, and is conversant on the legal implications of his opinions. In deposition, he sticks to those opinions which are relevant and essential for the claim. He is not flustered nor misled by opposing counsel. And yet, he does not portray even a hint of advocacy. He presents as a neutral observer who is just calling it as he sees it. Which, I believe, is entirely accurate. He will give an opinion he truly believes; no more, and no less. If you are lucky enough to have a case where his opinions are supportive of your position, he is a formidable and dangerous witness.

Dr. [redacted] case was dismissed. The Deputy District Attorney's request for dismissal was based on reports presented by the defendant that established that the work in question was performed.
